DIRECTIVE: The Department of Revenue previously required vendors who made sales for resale to out-of-state vendors to obtain a notarized statement from purchasers in lieu of a Massachusetts resale certificate. DOR will no longer require notarization so long as the seller has accepted, in good faith, a statement, either on the purchaser's letterhead or with a business card attached, signed by the purchaser under the pains and penalties of perjury. The statement must declare that:
